ORDER

UPON the order of Meade J dated 7 December 2022 (the "2022 Order")

AND UPON the application of the Applicant by notice dated 18 July 2023 to extend the operation of the 2022 Order (the "**Application**")

AND UPON reading the documents recorded on the court file as having been read

AND UPON considering the application on paper

IT IS ORDERED THAT:

1 Pursuant to paragraph 9 of the 2022 Order, the operation of that Order be extended for the 2023/2024 and 2024/2025 seasons of the Football Association Premier League competition, such extended order being in the form attached to this Order (the "**Extended Order**").

Sunset clause

- 2 The Extended Order (save for paragraph 3 below) shall cease to have effect upon the later of (i) 11 June 2025, or (ii) upon completion of the last Match Period of the 2024/2025 competition season, unless the Court orders otherwise.
- 3 The Applicant has permission to apply on or before the first Match Period of the 2025/2026 competition season to extend the operation of the Extended Order for a further period, such application to be supported by evidence and on notice to the Respondents.

Technical means

4 In the Extended Order, Schedule 4 of the 2022 Order shall be replaced with the contents of Schedule 2 of this Order.

Confidentiality

5 The Orders made under CPR r 31.22(2) and r 32.13(2) in paragraph 19 of the 2022 Order shall extend to the material identified in Schedule 1 of this Order, which shall also be treated as "Confidential Material" for the purposes of the Extended Order.

Other

- 6 The proceedings shall be stayed, save for the purposes of any application to give effect to the terms of this Order and save that the parties have permission to apply on notice in the event of any material change of circumstances including, for the avoidance of doubt but without limiting the generality of the foregoing, in respect of the costs, consequences for the parties and effectiveness of the aforesaid technical means from time to time.
- 7 Costs reserved, as to which the parties have permission to apply.
- 8 This Order shall be served by the Applicant upon each of the Respondents.

Schedule 4 of the Extended Order shall be replaced with the following:

In relation to the First Respondent (British Telecommunications plc)

- 1 In respect of its customers to whose internet service the system known as RedCard is applied, whether optionally or otherwise, the technical means are IP blocking.
- 2 For the avoidance of doubt, paragraphs 1 of the Order is complied with if the First Respondent uses RedCard or any subsequent system or measure that has equivalent relevant functionality.

In relation to the Second Respondent (EE Limited)

- In respect of its customers whose internet service is provided through its fixed line network currently known as EE Home line and mobile network (including its hosted Mobile Virtual Network Operators (MVNOs)), and to whose internet service the system known as RedCard applied, whether optionally or otherwise, the technical means are IP blocking.
- 4 For the avoidance of doubt, paragraph 1 of the Order is complied with if the Second Respondent uses the system known as RedCard or any subsequent system that has equivalent relevant functionality.

In relation to the Third Respondent (Plusnet plc)

- 5 In respect of its customers to whose internet service the system known as RedCard is applied, whether optionally or otherwise, the technical means are IP blocking.
- 6 For the avoidance of doubt, paragraph 1 of the Order is complied with if the Third Respondent uses RedCard or any subsequent system or measure that has equivalent relevant functionality.

In relation to the Fourth Respondent (Sky UK Ltd)

- 7 In respect of its customers to whose internet service the system known as Hawkeye is applied, whether optionally or otherwise, the technical means are IP blocking.
- 8 For the avoidance of doubt, paragraph 1 of the Order is complied with if the Fourth Respondent uses the system known as Hawkeye or any subsequent system that has equivalent relevant functionality.

In relation to the Fifth Respondent (TalkTalk Telecom Ltd)

- 9 In respect of its customers to whose internet access service the measure known as blackholing is applied, whether optionally or otherwise, the technical means are IP blocking.
- 10 For the avoidance of doubt, paragraph 1 of the Order is complied with if the Fifth Respondent uses blackholing or any subsequent system or measure that has equivalent relevant functionality, up to an overall limit under all live s 97A Orders to which the Fifth Respondent is subject of 10,000 simultaneous IP addresses.

In relation to the Sixth Respondent (Virgin Media Ltd)

- 11 In respect of its fixed-line residential and business retail broadband customers to whose internet access service the system known as Web Blocker 3 is applied, or to whose internet access the measure known as blackholing is applied, the technical means are IP blocking.
- 12 For the avoidance of doubt, paragraph 1 of the Order is complied with if the Sixth Respondent uses either the system known as Web Blocker 3 (or any subsequent system that has equivalent relevant functionality) or blackholing.

PUBLIC VERSION

UPON the order of Arnold J dated 25 July 2017 in these proceedings being varied and extended by the orders of Arnold J dated 18 July 2018, 26 March 2019, and 15 July 2019, by the orders of Birss J dated 20 May 2020 and 27 July 2020, and by the orders of Meade J dated 29 July 2021 and 7 December 2022 (as varied, the "**2022 Order**")

AND UPON the application of the Applicant by notice dated 18 July 2023 to further vary the terms of the 2022 Order (the "**Application**")

AND UPON reading the documents recorded on the court file as having been read

AND UPON the Court being satisfied on the evidence before it that the operators of the Target Servers (as defined in Confidential Schedule 2 to this Order) use the services of each of the Respondents to infringe the copyrights of the Applicant in the United Kingdom

AND UPON the Court recording that the Respondents are not wrongdoers and have not themselves infringed the Applicant's copyrights

AND UPON considering the application on paper

IT IS ORDERED THAT:

This order contains the following schedules:

Schedule 1 – Match Periods Schedule 2 – Target Servers (Confidential - omitted) Schedule 3 – Detection and Notification Criteria (Confidential - omitted) Schedule 4 – Technical Means Schedule 5 – Confidential Material

1 With effect from the date of this Order, the 2022 Order shall be varied and replaced with an Order in the following terms.

Disabling of access

- 2 The Respondents shall, during each of the Match Periods specified in Schedule 1 of this Order (as may hereafter be varied) or as otherwise required by this Order, block or attempt to block access to each of the IP addresses for the Target Servers (as defined in Confidential Schedule 2 of this Order) which during a Game Week:
 - (a) the Applicant or its appointed agent has detected:
 - during one or more Match Periods of that Game Week, is being used to communicate live match footage from a fixture of the 2023/2024 or 2024/2025 Football Association Premier League competitions ("Match Footage") to the public without authorisation; or
 - during the Pre-Monitoring Period (as defined in Confidential Schedule 3 of this Order) preceding one or more Match Periods of that Game Week, is being used to communicate to the public without authorisation live footage from:

- (A) a subscription television channel on which Match Footage is to be broadcast; or
- (B) a sports-related subscription television channel operated by the same broadcaster as a channel within sub-paragraph (A) above

(together, "Channel Footage"); or

- (iii) meets one or more of the detection conditions specified in Confidential Schedule 3 of this Order;
- (b) the Applicant or its appointed agent has concluded satisfies the requirements of Confidential Schedule 3 of this Order; and
- (c) is notified to the Respondents by the Applicant or its appointed agent in accordance with paragraph 5 of this Order during that Game Week or the immediately preceding Game Week.
- 3 Upon the expiry of each Match Period, the Applicant or its appointed agent will give a further notice to the Respondents in accordance with paragraph 6 of this Order to unblock all Target Servers that have previously been notified for blocking during that Match Period. The Respondents shall use their best endeavours to ensure that such unblocking occurs as soon as reasonably practicable after the expiry of the Match Period.
- For the avoidance of any doubt, paragraphs 2 and 3 of this Order are complied with by a Respondent if that Respondent uses the technical means set out in relation to that Respondent in Schedule 4 of this Order, or any alternative and equivalent (including replacement) technical means, provided that the Respondent gives notice to the Applicant of the change, and in respect of the customers identified in relation to that Respondent in Schedule 4 of this Order.

Notifications to the Respondents

5 Any notifications given by the Applicant or its appointed agent under paragraph 2 of this Order must:

- (a) be notified to the Respondents by means of publishing a list of all the IP addresses to be blocked on a secure electronic platform to which each of the Respondents has been given access by arrangement with the Applicant or its agent;
- (b) be published to the said platform at least twice during each Match Period, and (save as set out in paragraph 6 below) not during other periods; and
- (c) be published in such a manner that they are accessible to all Respondents as close to simultaneously as is reasonably practicable.
- Any notifications given by the Applicant or its appointed agent under paragraph 2 of this Order must be notified to the Respondents by the same means as those specified in paragraph 4 of this Order and given within 15 minutes of the expiry of the relevant Match Period, and shall be effected by publishing an empty list of IP addresses.

Time for compliance

- 7 When blocking access to an IP address pursuant to paragraph 2 of this Order, the Respondents shall use their best endeavours to disable access to the IP address as soon as practicable and subject to the limits of their networks and resources.
- 8 For the avoidance of any doubt, for a Respondent to comply with paragraph 7 of this Order it shall be sufficient for it to use the technical means set out in relation to that Respondent in Schedule 4 of this Order on at least two occasions during and prior to the expiry of a Match Period, or according to such other schedule as may be agreed between all of the Respondents and the Applicant in writing.

Sunset clause

- 9 This Order (save for paragraph 10) shall cease to have effect (i) on 11 June 2025, or (ii) upon completion of the last Match Period of the 2024/2025 Football Association Premier League competition season (whichever is later), unless the Court orders otherwise.
- 10 The Applicant has permission to apply on or before the first Match Period of the 2025/2026 Football Association Premier League competition season to extend the

operation of this Order for a further season, such application to be supported by evidence and on notice to the Respondents.

Notifications to third parties

- 11 Where the Applicant or its appointed agent notifies an IP address for blocking in accordance with paragraph 1 of this Order, it must within a reasonable period of the first occasion when that IP address is notified (being no later than the end of the next Match Period, or until the end of that day, whichever is earlier) send to the hosting provider associated with the IP address an electronic notice which contains the following information:
 - (a) that access to the IP address has been blocked in the United Kingdom by court order;
 - (b) the identity of the party who obtained this Order;
 - (c) a link to an internet location from which the public version of this Order may be accessed; and
 - (d) a statement that affected server operators have the right to apply to the Court to discharge or vary the Order.
- 12 Within 10 working days of this Order being implemented by a Respondent, that Respondent shall take reasonable steps to publish a statement to its customers (identified in relation to it in Schedule 4) in electronic form which contains the following information:
 - (a) that access to a number of (unidentified) servers associated with infringing Match Footage has been blocked by court order, and further similar blocks will continue for the duration of the Football Association Premier League 2023/2024 competition seasons;
 - (b) the identity of the party who obtained this Order; and
 - (c) a statement that affected users have the right to apply to the Court to discharge or vary the Order.

13 For the avoidance of doubt, the Respondents are not required to make the information in paragraph 12 of this Order available to their customers at the same time as blocking occurs.

Changes to Confidential Schedule 3

14 All parties have permission to apply in writing to vary the contents of Confidential Schedule 3, such application to be supported by evidence and on notice to all the other parties.

Suspension of blocking measures

- 15 A Respondent will not be in breach of this Order if it temporarily ceases to take the steps ordered in paragraph 2 (either in whole or in part) upon forming the reasonable view that suspension is necessary:
 - (a) in order to:
 - correct or investigate over-blocking of material which is, or is reasonably suspected to be, caused by the steps taken pursuant to paragraph 2;
 - ensure the reliable operation of its Internet Watch Foundation blocking system, if it reasonably considers that such operation is otherwise likely to be impaired;
 - (iii) maintain the integrity of its internet service or the functioning of its blocking system;
 - (iv) upgrade, troubleshoot or maintain its blocking system; or
 - (v) avert or respond to an imminent security threat to its networks or systems;
 - (b) and provided that:
 - (i) it notifies the Applicant or its appointed agent of such suspension and the reasons for the same as soon as reasonably practicable; and

(ii) such suspension lasts no longer than is reasonably necessary.

Permission to apply

- 16 The following persons have permission to apply on notice to vary or discharge this Order insofar as it affects them, namely:
 - (a) The operator of any server having an IP address notified under paragraph 2 of this Order;
 - (b) The operator of any website or video streaming service who claims to be adversely affected by this Order;
 - (c) Any recipient of a notice under paragraph 11 of this Order; and
 - (d) Any customer of the Respondents who claims to be adversely affected by this Order.
- 17 Any application under paragraph 16 of this Order shall be on notice to all the parties and be supported by evidence justifying the grounds for the application, including a clear indication of the status of the applicant.

Confidentiality

- 18 In respect of the material identified in Schedule 5 of this Order ("Confidential Material"):
 - (a) Pursuant to CPR rule 31.22(2), the parties and their external advisors and experts may only make use of the Confidential Material for the purposes of these proceedings, whether or not they are read to or by the Court, referred to at the hearing of the Application or in skeleton arguments;
 - (b) Pursuant to CPR rule 32.13(2), the Confidential Material shall not be open to inspection; and
 - (c) The Confidential Material shall, if mentioned, be excluded from electronic and hard copy transcripts of the proceedings.

Interpretation

- 19 In this Order:
 - (a) A reference to a "Match Period" is to be taken as a reference to any time which falls during one of the Premier League competition matches identified in Schedule 1 of this Order (whether that match in fact takes place at the time or on the date specified in Schedule 1), and includes:
 - The kick-off times which may in the future be published by the Premier League for any match fixture which has yet to be scheduled for broadcast;
 - (ii) Any changes to the kick-off time or date for a match fixture which are published by the Premier League from time to time; and
 - (iii) The period ending 30 minutes after the (currently or subsequently) scheduled end time for a match fixture.
 - (b) A reference to a "Game Week" is to be taken as a reference to the period between the first and last Match Period within each group of matches identified in Schedule 1, provided that if, as a result of re-scheduling of any match fixture, a match is in fact played during any of the times between the dates identified in Schedule 1 for each group of matches, the immediately previous Game Week (as identified in Schedule 1) will be treated as having been extended so as to include the period of that match.
 - (c) A reference to "the Applicant or its appointed agent" is to be taken as a reference to Football Association Premier League Limited or its appointed agent for the purposes of online enforcement, including the third party mentioned in Confidential Schedule 3 or such other agent as may be appointed from time to time.

Other

20 Upon details of the Match Periods and Game Weeks for the 2024/2025 Football Association Premier League competition being finalised by the Applicant, the Applicant shall serve an updated copy of Schedule 1 of this Order upon each of the Respondents by no later than two weeks before the first Match Period of that competition is due to commence.

- 21 The proceedings shall be stayed, save for the purposes of any application to give effect to the terms of this Order and save that the parties have permission to apply on notice in the event of any material change of circumstances including, for the avoidance of doubt but without limiting the generality of the foregoing, in respect of the costs, consequences for the parties and effectiveness of the aforesaid technical means from time to time.
- 22 Costs reserved, as to which the parties have liberty to apply.
- 23 This Order shall be served by the Applicant upon each of the Respondents.
